### Hospital system utilizes Allscripts Sunrise™ electronic health record (EHR) to achieve regulatory milestone

In September 2012, the Centers for Medicare and Medicaid Services (CMS) published a final rule that specified Meaningful Use Stage 2 criteria. Eligible providers (EPs) and eligible hospitals (EHs) need to demonstrate that their EHR systems supported these specific Meaningful Use Stage 2 criteria to ensure participation in CMS EHR Incentive Programs.

"CTH is very proud to be included among the first 2014 Meaningful Use Stage 2 inpatient attestations," said Beck. "This an important milestone and a product of the hard work and commitment of CTH's clinicians and staff. It is also an indication of CTH's ongoing dedication to the health and wellness of patients in the communities we serve."
