

Royal Adelaide Hospital goes live with Allscripts EHR solution

The \$2.3 billion hospital, the second most expensive building in the world, will provide care to about 85,000 inpatients and 400,000 outpatients per annum.

The Royal Adelaide Hospital is promising to be a genuine 'high tech hospital of the future.' From stainless steel high-tech robots that can talk to lifts, doors and portable phones and carry goods around the hospital to a pneumatic tube system that transports specimens to 74 stations, this is one of the world's most advanced health facilities in the world and it is only appropriate that Allscripts Sunrise is the hospital's electronic health record.
